We coordinate efforts in conservation, safety, recreation, riparian restoration and water quality among local agencies in the Fargo-Moorhead area and events for current and future leaders designed to build a sound foundation for science-based decision making. One of the ways we promote stewardship is to work with about 2000 volunteers annually to conduct our Storm Drain Marking Program, plant trees and shrubs in the degraded riparian area, conduct water quality monitoring, pick up garbage in and along the river and more. We teach people to use the river safely through our adult and youth fishing clinics, Paddling Excursions, and Race the Red canoe and kayak races as it's been
